
or mere criminals, this study looks at how contemporaries understood their behaviour, arguing that there was a wide range of views – which often included praise for clerics who fought in licit causes

## ARMSBEARING AND THE CLERGY IN THE HISTORY AND CANON LAW OF WESTERN CHRISTIANITY

In the first millennium the Christian Church forbade its clergy from bearing arms. In the mid-eleventh century the ban was reiterated many times at the highest levels: all participants in the battle of Hastings, for example,

who had drawn blood were required to do public penance. Yet over the next two hundred years the canon law of the Latin Church changed significantly: the pope and bishops came to authorize and direct wars; military-religious orders, beginning with the Templars, emerged to defend the faithful and the Faith; and individual clerics were allowed to bear arms for defensive purposes.



## CRUSADING SPIRITUALITY IN THE HOLY LAND AND IBERIA, C.1095-C.1187

For much of the twelfth century the ideals and activities of crusaders were often described in language more normally associated with a monastic rather than a military vocation; like those who took religious vows, crusaders were repeatedly depicted as being driven by a

desire to imitate Christ and to live according to the values of the primitive Church. This book argues that the significance of these descriptions has yet to be fully appreciated, and suggests that the origins and early development of crusading should be studied within the context of the "reformation" of professed religious life in the twelfth century.




their activities in their administrative heartland in south-west France.
