



### **Everything harder than everyone else**


Why some of us push our bodies to extremes

### **JENNY VALENTISH**

It's human nature to test our limits. But what happens when this comes to define you?

When Jenny Valentish wrote a memoir about addiction, she met some who treated drug-taking like an Olympic sport, forcing their bodies to the edge, enjoying the notoriety. When they got sober, the obsession just changed form: they took up marathon running, or freediving, or rock-climbing, Instagramming from mountaintops. What stayed constant was the need to push their boundaries. In this wildly compelling read, Jenny's fascination with what drives some to obsession leads her on her own compulsive journey. Speaking to those who live for the extreme, she finds a curious Venn diagram can be drawn: retired porn stars put on wrestling leotards, neuroscientists become extreme eaters; dog-tired MMA fighters roleplay BDSM. Is this need for adrenaline hard-wired, or is the sense of self so shaky that letting go of one persona requires throwing on another? And what does this mean for Jenny's new obsession? From abstinence to ego, mastery to addiction, rage to reinvention, our compulsions are intertwined with our personas. Darkly funny and vividly penetrating, *Everything Harder Than Everyone Else* explores our deeper selves and asks: what are your limits?


### **VITTORIO BUFACCHI**

French philosopher Michel de Montaigne (1533–92) said that facing our mortality is the only way to learn the 'art of living'. He was right. This book is about what we can learn from COVID-19, as individuals but also collectively. It argues that this crisis could change our lives for the better, ushering in a more just society.

Exploring eight themes through philosophical lenses, the book asks whether COVID-19 is a misfortune or an injustice, considers the largest cohort of victims (people in old age) and discusses whether life under lockdown is comparable to life in the so-called 'state of nature'. It explores the likely impact of the virus on the global phenomenon of populism and analyses the relationship between COVID-19 and post-truth. One chapter is dedicated to the role of arguably the most important players in the response to the pandemic: the experts. The book ends by considering the spike of reported cases of domestic violence during the lockdown via an analysis of the BBC adaptation of Sally Rooney's novel *Normal People*.





He travels between Leonora's native England and adopted homeland of Mexico, making stops in New York and Paris and meeting some of the remarkable figures she associated with, from Max Ernst and André Breton to Remedios Varo and Alejandro Jodorowsky. ### **Dreams of disconnection**


From the autonomous house to the self-sufficient city

Why must we live in homes and in communities built around a shared grid for our needs? For over a century, creative architects and urbanists have dreamed of self-sufficient living, whether to cut themselves off from society or in preparation for some external threat, be it climate change or nuclear war.

Dreams of disconnection tells the story of this strand of design and planning, from its pioneers in the late-nineteenth century to those applying similar ideas two hundred years later. Fanny Lopez takes in many a utopian visionary in her tour of dreamers of disconnection, from theorists and architects to industrialists and engineers. Technology and design are the centre-pieces for these projects, and their complexity, particularly around sustainable supplies of energy, food and water, often find solutions in aesthetics. The book demonstrates that whether these dreams were based around single homes or whole cities, there is much to be learned and marvelled at in the history of self-sufficient design.







(B) ordering Britain argues that Britain is the spoils of empire, its immigration law is colonial violence and irregular immigration is anti-colonial resistance. In announcing itself as postcolonial through immigration and nationality laws passed in the 1960s, '70s and '80s, Britain cut itself off from its colonies and the Commonwealth, taking with it what it had plundered. This imperial vanishing act cast Britain's colonial history into the shadows. The British Empire, about which Britons know little, can be remembered fondly as a moment of past glory, a gift once given to the world. Meanwhile immigration laws are justified on the basis that they keep the undeserving hordes out. In fact, these laws are acts of colonial seizure and violence. They obstruct the majority of racialised people from accessing wealth amassed in the course of colonial conquest. Regardless of what the law, media and political discourse dictate, people with personal, ancestral or geographical links to colonialism, or those existing under the weight of its legacy of race and racism, have every right to come to Britain and take back what is theirs.


# Black resistance to British policing

As police racism unsettles Britain's tolerant self-image, Black resistance to British policing details the activism which made movements like Black Lives Matter possible. Adam Elliott-Cooper analyses racism beyond prejudice and the interpersonal – arguing that black resistance confronts a global system of racial classification, exploitation and violence.

Imperial cultures and policies, as well as colonial war and policing highlight connections between these histories and contemporary racisms. But this is a book about resistance, considering black liberation movements in the twentieth century while utilising a decade of activist research covering spontaneous rebellion, campaigns and protest in the twenty-first century. Drawing connections between histories of resistance and different kinds of black struggle against policing is vital if we are to challenge cutting-edge police and prison power that harnesses new and dangerous forms of surveillance, violence and criminalisation.

This book makes the case for an inclusive form of socialist feminism that puts women with multiple disadvantages at its heart. It moves feminism beyond contemporary disputes, including those between some feminists and trans women. Combining academic rigour with accessibility, the book demystifies some key feminist terms, including patriarchy and intersectionality, and shows their relevance to feminist politics today. It argues that the analysis of gender cannot be isolated from that of class or race, and that the needs of most women will not be met in an economy based on the pursuit of profit. Throughout, the book asserts the social, economic and human importance of the unpaid caring and domestic work that has traditionally been done by women. It concludes that there are some grounds for optimism about a future that could be both more feminist and more

### Me, not you


The trouble with mainstream feminism

### **ALISON PHIPPS**

The Me Too movement, started by Black feminist Tarana Burke in 2006, went viral as a hashtag eleven years later following a tweet by white actor Alyssa Milano. Mainstream movements have often built on and co-opted the work of women of colour, while refusing to learn from them or centre their concerns. Far too often, the message is not 'Me, Too' but 'Me, Not You'. Alison Phipps argues that this is not just a lack of solidarity. Privileged white women also sacrifice more marginalised people to achieve their aims, or even define them as enemies when they get in the way.

Me, not you argues that the mainstream movement against sexual violence expresses a political whiteness that both reflects its demographics and limits its revolutionary potential. Privileged white women use their traumatic experiences to create media outrage, while relying on state power and bureaucracy to purge 'bad men' from elite institutions with little concern for where they might appear next. In their attacks on sex workers and trans people, the more reactionary branches of this feminist movement play into the hands of the resurgent far-right.





Many disenchanted Kashmiris continue to demand independence or freedom from India. Written by a leading authority on Kashmir's troubled past, this book revisits the topic of independence for the region (also known as Jammu and Kashmir, or J&K), and explores exactly why this aspiration has never been fulfilled. In a rare India-Pakistan agreement, they concur that neither J&K, nor any part of it, can be independent.

Charting a complex history and intense geo-political rivalry from Maharaja Hari Singh's leadership in the mid-1920s to the present, this book offers an essential insight into the disputes that have shaped the region. As tensions continue to rise following government-imposed COVID-19 lockdowns, Snedden asks a vital question: what might independence look like and just how realistic is this aspiration?






