There is a significant addition to our law list, *The basics of international law* (p. 8). You will also find our art history and literature lists as vibrant as ever. They boast the first book on punk artist Gee Vaucher (p. 28) and a new book on Leonora Carrington (p. 27). There are also books on William Blake (p. 16) and Nietzsche (p. 16), as well as the first biography of Hanif Kureshi (p. 17) and a new collection on David Foster-Wallace (p. 17).



We are also very pleased to see that medieval and early modern history, colonialism and imperialism remain key areas for MUP. So why not dive in and enjoy this season's offering!
