PATTON'S WAR

AN AMERICAN GENERAL'S COMBAT LEADERSHIP VOLUME 3: JANUARY 1-DECEMBER 21, 1945



The beginning of the highly anticipated third and final volume of Kevin Hymel's acclaimed *Patton's War* trilogy finds Lieutenant General George S. Patton on January 1, 1945, as master of the battlefield in World War II Europe just as he and his Third Army prepare to close the German bulge in the American lines: a task that involved linking up with the First Army in Houffalize and reclaiming the German army's gains during the Battle of the Bulge.

Subsequent months proved equally remarkable, as Patton and his soldiers invaded Germany, secretly crossing the Rhine on March 22. Afterward, Patton made his only tactical mistake when the Germans destroyed a task force sent to liberate a POW camp where his son-in-law was imprisoned.

In writing this third volume, Hymel draws from Patton's original diaries (not the transcribed, embellished versions historians have relied on for years) and letters, as well as from various archives, to tell the general's story. Perhaps the most valuable aspect of Hymel's work is that Patton emerges not as a larger-than-life myth but as a human being, one held back by personal prejudices and other failings that led to his demise. Despite noting these flaws, Hymel reveals that Patton was, above all, a commander determined to win, or, as the general himself might put it, getting the enemy to dance to his tune.

Kevin M. Hymel is a contract historian at Arlington National Cemetery and a Historian/Tour Guide of Ambrose Historical Tours, leading the "In Patton's Footsteps" tour. He lives in Arlington, Virginia.



While working on his first book, Bob Korkuc became intimately familiar with the 381st Bombardment Group of the Mighty Eighth Air Force and met the group's chaplain, James Good Brown. Brown kept a diary during his time with the bomb group (1943 to 1945) in which he chronicled the daily experiences of the men.

Years after the war, Brown self-published his diary, which today is hard to find. Through his friendship with Brown, Korkuc gained access to and chose to edit the original document so that more readers might appreciate this insightful wartime eyewitness account.

Serving in his early forties alongside men twenty years his junior—whom he called the "Mighty Men of the 381st"—Brown took part in morning briefings, shared meals with crews, and anxiously awaited their return from dangerous daylight bombing missions. Writing with extraordinary candor, Brown documents the inner workings of a bomb group that flew 297 combat missions over Europe, providing vivid character assessments of his fellow airmen and capturing both their victories and devastating losses.

In addition to judiciously editing Brown's original diary for readability, Korkuc created a unique appendix, which reveals the fate of every airman who served with Brown. The immediacy of Brown's narration combined with Korkuc's meticulous editing make this a promising new resource for scholars and general readers alike.



Throughout 1884, Mark Twain's most famous work, *The Adventures of Huckleberry Finn*, underwent the tumultuous final stages of production. During the same year, Twain launched his own publishing house, embroiled himself in presidential politics, embarked on a months-long lecture tour with George Washington Cable, thwarted a suicide attempt, found inspiration for his next novel, and attempted to master riding a high-wheeled bicycle called a velocipede—and these are merely the highlights.

In Mark Twain's 1884: A Pivotal Year in the Life, John Bird takes a "micro-biographical" approach to Twain's life by focusing on this single year during which Twain stood at the height of his powers as a writer and enjoyed some of the happiest times with his family. The book's day-to-day structure allows the reader to live through this year alongside the famous author. His work, family life, correspondence, business dealings, travels, and other pursuits are all explored in vivid detail. Bird's fresh approach gives readers a broader view not only of Mark Twain as an author and celebrity, but of Mark Twain the father, uncle, husband, and friend.

John Bird is Emeritus Professor of English at Winthrop University and is the author of *Mark Twain and Metaphor*, and editor of *Mark Twain in Context*. He lives in Calabash, North Carolina.



The story of Jeffrey Deroine defies stereotypes. Born in St. Louis in 1806 of both French and African ancestors, Deroine spent much of his life among Indigenous people. Although born into slavery, he gained his freedom and became a successful businessman and property owner who enslaved others. His story illustrates the complex history of Missouri and the West.

Though specifics are elusive, historian Greg Olson skillfully traces Deroine's life, recounting his journey from enslaved worker in the fur trade to free person of color, aided along the way by the Ioway Nation. Deroine became a US government interpreter for the Ioway, helping them negotiate treaties, before running his own trading business and participating in the founding of St. Joseph, Missouri, where he became one of the first people of color to own property in the state. Throughout the book, Olson shows us that, for all its extraordinary qualities, Deroine's story offers valuable insights into a crucial era in Missouri's history, as well as the multicultural intersectionality of life in 19th-century America.

Greg Olson served as the Curator of Exhibits and Special Projects at the Missouri State Archives from 2000 to 2018 and is the author of six books, including, *Indigenous Missourians: Ancient Societies to the Present*. He lives in Columbia, Missouri.



Environmental degradation has been part of American life for centuries, and yet environmental journalism as a specialized reporting beat has only existed since the 1960s. Since then, coverage of the environment has not always been a priority for news organizations. Moreover, journalists who pursue environmental stories have long been criticized as activists, a charge that discredits their work and undermines the value of environmental reporting.

In *The Environmental Beat*, Comfort examines the circumstances in which news organizations began to invest in environmental journalism since the early 20th century, and demonstrates how the right mix of external social factors and internal newsroom dynamics must occur for the environment to appear newsworthy. Her exploration of the long history of environmental journalism and thoughtful analysis will appeal to working journalists, students of journalism, and the interested public alike.



What might the members of the first Virginia assembly think if they could visit today's Virginia House of Delegates? The air-conditioning and diversity of the current membership surely would surprise them, but would the legislative process itself strike them as odd? In his latest work, Peverill Squire demonstrates that the way the modern legislature goes about its work would seem familiar to visitors from the past.

In his latest work, Squire traces a nearly uninterrupted path from that first assembly in Virginia in 1619 to the contemporary Virginia General Assembly, and to the U.S. Congress and the other forty-nine state legislatures. Each chapter examines discrete topics rather than historical eras, distinguishing the book from other studies of American legislatures. Topics covered include the fundamentals of legislative structure and operation, how qualification standards for legislative service became more inclusive, and how legislative professionalization unfolded at both congressional and state levels. Though covering more than 400 years, Squire manages to present a comprehensive and accessible history of American legislatures that both scholars and students will find valuable.

Peverill Squire holds the Hicks and Martha Griffiths Chair in American Political Institutions at the Truman School of Government and Public Affairs at the University of Missouri. He is the author of several books, including *Reforming Legislatures: American Voters and State Ballot Measures, 1792–2020.* He lives in Columbia, Missouri.
