

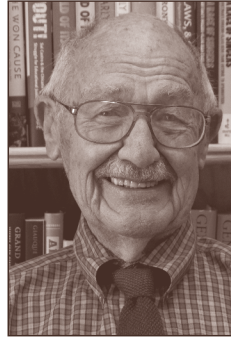
MAKING A DIFFERENCE

When you create or revise your estate plan, we hope you will include the University of North Carolina Press among your beneficiaries.

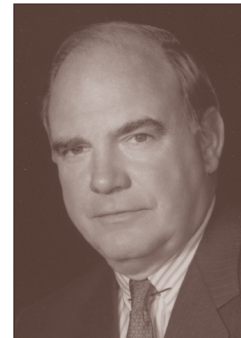

CHOOSE THE PLANNED GIFT THAT WORKS FOR YOU

There are numerous ways you can make a planned gift to support the Press:

- **Bequests** are uncomplicated arrangements in which you name the Press as a beneficiary in your will. A bequest is simple to arrange, allows you to retain your assets throughout your lifetime, and permits you to designate a specific dollar amount, a percentage of your estate, or a particular asset. A bequest to the Press may also reduce the taxes on your estate.

- **Retirement plans**, such as IRAs and 401(k)s, are an ideal asset to give to the Press because they are easy to allocate and can be a wise tax strategy. Simply designate the Press as a beneficiary of your retirement plan.

- **Trusts**, such as charitable remainder trusts and charitable lead trusts, can take several forms with several benefits. The Press does not need to be named as trustee for you to designate the Press as a beneficiary.

- **Insurance policies** are also a straight forward gift you can give. Simply designate UNC Press as a beneficiary of your policy, or if you no longer need the policy, gift the policy to the Press.

FREQUENTLY ASKED QUESTIONS

Q: Is it difficult to make a planned gift?

A: No. For beneficiary designations (retirement or life insurance), contact your plan administrator for a change of beneficiary form, on which you list “The University of North Carolina Press, Inc.” as the primary beneficiary for all or a portion of the account. If you already have a will, you can add the Press as a beneficiary with a phone call to your attorney to prepare a codicil.

Q: Is there a typical planned gift?

A: No. Your planned gift will be what is right for you. UNC Press has received gifts ranging from \$500 to \$500,000.

Q: What assets can I leave to the Press?

A: You may designate:

- A specific cash amount
- A percentage of your estate or assets
- The residual of your estate after your heirs are provided for
- Financial investments, such as stocks, bonds, or certificates of deposit
- UNC Press as the beneficiary of your life insurance policy or your retirement plan
- Items such as art, antiques, jewelry, real estate, or copyrights

Q: Do I have to let the Press know about my planned gift?

A: No. However, by informing us about your plans, you give UNC Press the opportunity to recognize you during your lifetime, you give yourself peace of mind knowing your intentions have been communicated clearly, and you give others the inspiration to follow your lead. Informing us does not make your gift binding. You may change your estate plan if your circumstances or priorities change.
