Director's Letter

Looking for Normal in the New Normal

2021 was a year filled with contradictions for UNC Press. Like all of you, we navigated life and work during a stubbornly persistent global pandemic. Every day the staff confronted the challenges of maintaining focus and productivity while keeping themselves and their families safe. I know from speaking with many individuals here that this has exacted an enormous toll on their mental health. And yet the contradiction is that the Press and Longleaf Services are generating historically successful results. We've published more books, generated more acclaim, and managed our finances more successfully than ever before.

I hope that staff members are able at some point to reflect on what they've accomplished. When everything around us feels broken and unsustainable, the community of students, teachers, scholars, librarians, booksellers, and readers everywhere that rely on us are grateful that the Press has been so stable and productive. As we prepare this report during yet another low moment in the cycles of the pandemic, I remain optimistic that we can continue to generate this type of impact. But in the coming year, we need to achieve it in ways that are more sustainable and rewarding for our staff.

The Departments of the Press

While we are here to support authors, and books will always be the vehicle we use to measure our impact, one of the reasons we invest in the creation of this report is so our readers can meet the people who perform the labor to support our authors. I encourage you to take a few moments to read about the staff who do this work. A chart of activities on page 3 illustrates the multiple, overlapping steps we piece together to successfully publish books.

For many of you, the acquisitions department (see p. 12-13) is the face of the Press. That department continues to grow, as does the number of books it acquires. You'll read about four new series we've launched this year—more than we had launched in my previous nine years here and an indicator of our ambitious growth plans. Our editorial/design/production team (see p. 10) is also growing and continues to make miracles small and large happen every day in getting copyed-itors and designers and printers to stay on schedule.

Our marketing group (see p. 11) is consistently finding new ways of helping our authors find new readers. Our operations would not be possible without the efforts of the many people behind the scenes that support the general administration at the Press (see p. 11), from the business and finance staff who have worked tirelessly (and frequently on location in Brooks Hall) to ensure that our business runs smoothly and effectively, to the development efforts and publishing services staffs at Longleaf Services and the Office of Scholarly Publishing Services.

Building Capacity to Support Continued Growth

The Press is increasing the number of books and journals we publish, which requires growing the staff and the supporting systems they use. Several key new positions were added this year, including an art director and associate digital marketing manager. We developed a new web-based author portal. This tool allows our authors to interact with us more efficiently and quickly while enabling us to make sure questions and requests for support are being trafficked to the correct department. In addition, we began a program of creating "in-house" audio editions of our books. Audio content is the fastest-growing segment of the book business, and although third-party companies are available to do this work, they only accept a small fraction of our new books. We want to have a larger role in managing that process going forward. We also continue to expand our Open Access (OA) efforts. This year we published on our website a new OA Vision and Policy that explains why we see expanding accessibility as a key strategy in increasing our impact and achieving greater equity.

Diversity, Equity, and Inclusion (DEI)

DEI continues to be a focus for us, although developing new initiatives and reflecting on our progress has been very challenging during the pandemic. Nevertheless, we undertook three major new efforts this year, including one with our trade group, the Association of University Presses, to develop and participate in a new data-gathering exercise. Additionally, we are introducing new online tools to encourage broader participation by our staff at key internal meetings. And we are preparing a public-facing progress chart of our accomplishments and goals. Our hiring practices have improved, resulting in a staff that more closely reflects the diversity of our region. Most importantly, more and more of our daily activities are being considered through a DEI lens.

Longleaf Services

UNC Press owns the publishing services platform Longleaf Services (see pp. 34–35), which provides economies of scale and skill for us and seventeen other university presses. Longleaf also experienced record levels of activity and success, allowing us to invest in more tools and staff to make publishing more efficient for our presses. We continue to participate in several grant-funded initiatives—the Sustainable History Monograph Pilot (supported by the Andrew W. Mellon Foundation) and Next Generation Library Publishing (supported by the Arcadia Fund)—to advance accessibility and expand publishing channels.


Office of Scholarly Publishing Services (OSPS)


Now in its sixth year, OSPS (see pp. 36–39) is primarily focused on supporting publishing activity that originates on the campuses of our statewide system. This can include journals, institutional histories, archival collections, and myriad other publications. This year has seen rapid growth in publishing free digital (and low-cost print) textbooks. These publications will significantly benefit students throughout the UNC System, generating thousands of dollars of savings for them annually.

Retirements and Passings

Two of our longtime employees retired this year (see p. 17). Jay Mazzocchi and Rebecca Evans both worked in our editorial/design/production department shepherding countless authors and manuscripts through the publishing process. We're grateful for their years of excellent work and congratulate them on achieving this well-deserved milestone.

We lost several dear members of our community this year. UNC Press was one of the many North Carolina institutions that benefited from the wisdom and consideration of John Sanders, a well-respected and exemplary public servant. Most notably, through his service to the Press's Board of Governors and legislation he drafted, John cemented UNC Press as the singular



university press for the sixteen-campus consolidated University of North Carolina. Historian and teacher Julian Pleasants was a scholar deeply engaged with the state of North Carolina. We were fortunate to publish several of his books. In addition to his intellect, Towny Ludington brought warmth and humor to the Press both

as an author of A Modern Mosaic: Art and Modernism in the United States and as a long-serving member of the Board of Governors. We lost another former author and board member, Philip Stadter. One of our recent authors, Stephen Ash, died unexpectedly this year. Sandra Eisdorfer, former managing editor at the Press, also passed away. As her children wrote to me, she was always a champion of the art of writing.

A Note of Gratitude to Eric Muller

This year marked the last year of service for Professor Eric L. Muller. former board member and chair. His more than a decade of service was marked by a tireless dedication to advancing the mission of the Press. During his term as board chair, he oversaw the growth and improved financial state of the Press. We created our Office of Scholarly Publishing Services, substantially expanded Longleaf Service, and diversified membership of the board itself—among many other achievements. On a personal note, for me he was a confidant, advisor, critic, advocate, and friend. He made me a better director, and the University of North Carolina System has a significantly better Press because of his work. I know I speak for the staff and community of Press supporters when I say thank you, Eric. We were fortunate to have you as a colleague.

As I always do in this space, I want to offer a special note of gratitude to any reader of this report who has donated to the Press this past year. As you can see from our development report (see pp. 40–49), there are many of you. The generosity of donors has been one of the key elements in making UNC Press excellent and allowing us to succeed even during these trying times. Thank you.



About the Press

The University of North Carolina Press, a nonprofit publisher of both scholarly and general-interest books and journals, operates simultaneously in a business environment and in the world of scholarship and ideas. The Press advances the university's triple mission of teaching, research, and public service by publishing first-rate books and journals for students, scholars, and general readers. The Press has earned a distinguished reputation by publishing excellent work from the nation's leading scholars, writers, and intellectuals and by presenting that work effectively to wide-ranging audiences.

Established in 1922, UNC Press was the first university press in the South and one of the first in the nation. Our regional publishing program—aimed at general readers and offering engaging, authoritative work on all aspects of the region's history and culture, its natural and built environment, and its music, food, literature, geography, and plant and animal life—has been widely adopted in other parts of the country. Over the years, Press books have won hundreds of prestigious awards including the Pulitzer Prize and the National Book Award and those of many national scholarly societies. Today, the imprint of UNC Press is recognized worldwide as a mark of publishing excellence—both for what we publish and for how we publish. Because of our respected authors who rely on the Press to connect readers with important ideas, the name of the university is carried on Press books and journals across the country and around the globe, in both print and digital formats.

To promote generally, by publishing deserving books, the advancement of the arts and sciences, and the development of literature.... The stimulus to the intellectual life of the university and of the entire South is, in itself, sufficient argument for undertaking the project.

Board of Governors

The Board of Governors of UNC Press is a body of nineteen members, fifteen of whom are elected by the Board of Governors of the University of North Carolina and four of whom serve ex officio, charged with the responsibility of directing the affairs of the Press. This includes establishing and monitoring all policies and programs for the maintenance, operation, and improvement of the Press, including its publishing policies and projects and its budget and financial policies.

A member's responsibilities include attending board meetings; reviewing and voting on approval of monographs, series, and other publishing projects of the Press; consulting with and advising the director of the Press on matters of financial and publishing policy and strategy; and serving as needed on ad hoc or standing committees.



Sources of Income

The chart below shows the many sources of income here at UNC Press and how the diversity of these income streams insulates us from the short-term fluctuations in any one part of the operation. Within these different streams of income, there are three general categories: sales revenues, state support, and development. 2021 was an exceptional year when our sales revenues increased by almost 40% over historical trends, resulting in some unusual patterns.

The Press operates primarily as a cost-recovery enterprise with revenues coming from a variety of business units. This includes sales of books and journals, but also income from subsidiary rights and publishing services activities. These proceeds usually cover around 70% of our expenses, but in this exceptional year, that percentage was closer to 87%. The second major source of income is the fixed support we receive through the state and university system. We were also grateful to receive a onetime NEH CARES Grant from the National Endowment for the Humanities. These funds arrived early in the year, providing the financial stability which allowed us to thrive later in the year. Together, these funds covered 8% of our expenses.

Finally, we have a robust development program that includes our endowment and annual giving initiatives. In most years, development efforts cover around 18% of our expenses. Because of our strong sales finish, the endowment draw only needed to cover 8% of expenses, leaving more available in future years when sales are not as strong.



The Departments of the Press

With almost forty full-time employees, the staff manages all aspects of our business, including the full range of the publishing process. Their efforts can be broken into five primary departments.

The Acquisitions department oversees the development of the list of books to be published. A full description of the team that acquires our books can be found on page 12. The Editing, Design, and Production department is responsible for the overall production of books. Manuscript Editorial is responsible for editing and shepherding through production the manuscripts accepted for publication. Design and Production is responsible for the physical appearance of the book and supervises design and typesetting as well as manufacture by outside firms.

Editorial Director's Letter

Dear Friends,

The past year demanded a great deal from all of us. The need for constant adaptation in our personal and professional lives has strained the creative work at the heart of the acquisitions team's relationships with authors, advisors, and colleagues. In summing up the story of our year, I want to point to the resilience and dedication of each individual member of our team. In ways large and small, each one has maintained a focus on our mission and our long-term vision, even when the short-term outlook has been profoundly uncertain.

Understandable delays in authors' manuscript submissions at the start of 2021 placed considerable strain on our workflows, as did an unexpected period of staffing transition that continued to ripple through much of the year. The operational stress of these developments flowed from our team throughout the organization. To address these challenges, we joined our colleagues in a temporary strategic reduction of the number of manuscripts transmitted for publication. But despite this short-term reduction in title count, our editors contracted for a historically high number of new works, continuing to lay groundwork for strategic growth that we have envisioned as the Press begins its second century. As we prepare to review and transmit a larger number of books, we have given special attention to new staffing, workflows, procedures, and tools that will help us remain resilient and effective as a hybrid team of on-site and remote colleagues; this work will continue into 2022.

We have planted additional seeds for future growth in the creation of several new book series. Series are a key tool in the development of a university press's book list and in every respect a strategic investment, generally requiring several years of planning and development before a first book appears. New series can establish a visible commitment in an area of emerging interest, galvanize the reputational strength of an existing list, or give special, sustained attention to a significant subfield or approach. Series editors become key partners as we identify and develop new work around a consistent set of subjects, methods, or themes.

Four new series are now in the process of launch. "The Boundless South," edited by Karen Cox and Françoise Hamlin, features books about our region that are readable and deeply researched while pushing the boundaries of what makes a "southern history." Edited by Michael Innis-Jiménez and Lori Flores, "Latinx Histories" represents an expanded investment in work that centers Latinx people in the full sweep of American and world history. "Black Women's History," edited by Talitha LeFlouria, Ashley Farmer, and Daina Ramey Berry, will support the renaissance of scholarly and general interest work in a field with distinctive historiography, archives, and methods. And finally, a new series in creative nonfiction, "Great Circle Books," was approved by the Board of Governors late in the year, helmed by series editors Kiese Laymon and Marie Mutsuki Mockett.

In December we also announced a major new partnership with Reacting Consortium, Inc., based at Barnard College, around their innovative game-based historical pedagogy called Reacting to the Past.[™] Via this partnership, the Press will publish a series of textbooks, each based on a history game developed through an extensive process of review, testing, and approval by the Reacting Consortium. The Press has acquired the publishing rights to nineteen previously published textbooks that are now being converted for release by July 1, 2022. We have also secured the Board's approval to republish under the UNC Press imprint ten more works that had been produced under the Reacting Consortium's own imprint (with support from the Press's Office of Scholarly Publishing Services). Going forward, we expect this initiative will produce two to four new textbooks a year.

This brief letter never provides enough space to call out the individual achievements of our team members, the service they provide to the academy and the industry, or the major awards won by our authors and books. But I would be remiss if I did not mention a very special recognition for our retired colleague Chuck Grench. In October 2021 we learned that Chuck had been honored by the Western Historical Association with its Gordon Bakken Award of Merit, a "lifetime achievement" honor recognizing outstanding service to the field and to the association. It was a wonderful reminder not only of Chuck's outstanding work at UNC Press but also of the way all editors engage the world of ideas and seek to influence that world beyond any annual list of books published.

We are grateful to you for your support of our work and wish you a year of happy reading.


WE ARE EXCITED that two important textbook initiatives came to fruition in 2021 after years of collaborative work by faculty teams. The first is *Contemporary Precalculus through Applications* from the North Carolina School of Science and Mathematics. The second is the *Global Humanities Reader* from the UNC Asheville Humanities Program. Details about these projects follows on pages 38-39.

These books join a growing list (below) of affordable access and open access textbooks that are helping to lower costs for students in the UNC System and beyond. Publishing a textbook comes with significant up-front costs and effort. Each book on this list was developed by dedicated faculty knowing they would not be paid the kind of royalties they might expect from a commercial publisher.

They join 45 other departments, libraries, and research centers across eleven institutions in the UNC System that work with us on their publishing initiatives. As UNC Press turns 100 (and OSPS turns seven) we're excited to build more partnerships across the system.



In 1991, the North Carolina School of Science and Mathematics published a groundbreaking textbook, *Contemporary Precalculus through Applications*, which went on to sell 25,000 copies and was used in 200 high schools, community colleges, and universities. This third edition brings the book fully up to date, incorporating the use of graphing calculators and other computing technology not available to students for previous editions.


Textbooks from commercial publishers are notoriously expensive—often as much as \$150 including supplemental materials. *Contemporary Precalculus through Applications* is available in an open access digital format and in paperback for \$38, offering meaningful savings for students and school districts.

"We are excited to build on our long history of supporting math education and math educators across North Carolina and beyond," said Taylor Gibson, Dean of Mathematics. "We hope that by offering our digital textbook for free, teachers and students will have a valuable resource with which to promote the joy and beauty of learning mathematics in their classrooms."

The UNC Asheville Humanities Program has a reputation as one of the strongest undergraduate programs of its kind, earning recognition from the National Endowment for the Humanities, the Association of American Colleges and Universities, *Fiske Guide to Colleges, The Princeton Review,* and *U.S. News and World Report.* Students focus on ancient, premodern, and modern cultures and societies as they progress from freshman to junior year with primary source readings serving as a core teaching resource.


"The texts that have been in use, and revised a few times over the nearly 60-years of the program, have traditionally been called the Asheville Readers," said Katherine C. Zubko, Ph.D., Professor of Religious Studies, NEH Distinguished Professor in the Humanities. "Since our last revision in 2003, the courses have shifted in their curriculum to encompass a wider variety of cultures and perspectives so that they are truly global for the first time—updating the readers was a must to match that shift."



In 2017, a faculty team led by Zubko and Keya Maitra, Ph.D., Professor of Philosophy, Thomas Howerton Distinguished Professor of the Humanities, began a project to completely revise the readers and to incorporate more engaging teaching elements such as timelines. A 2017 grant from the Andrew W. Mellon Foundation helped to jumpstart the editorial process. Four years and many hours of hard work later, the new *Global Humanities Readers* are available in low-cost print and digital formats, including digital hosting on NC LIVE which makes them widely available in North Carolina libraries.




