Director's NC Letter

I'm incredibly proud to share with you this report that describes our many accomplishments in the last year. One of the highlights was our return to a more normal way of working since the pandemic. We also benefited from significant stability in our staff—and even were able to create some new positions. Despite a turbulent economy, we had a successful year from a business perspective as well, and began implementing plans to grow our book program over the coming years.

This isn't to say that we didn't face some serious challenges. Book sales, for example, which skyrocketed during the pandemic, have come crashing back to earth. And while it was gratifying to be able to modernize some of our system infrastructure last year, it was very disruptive. We also wished a bittersweet farewell to the various celebrations commemorating the Press's centennial. These challenges notwithstanding, I'm as grateful as ever for how hard the staff here works every day to ensure that this institution—which is a source of pride for all of us—continues to be a leading force at our university, as well as within the state, the region, and beyond.

Our book publishing program will always be the centerpiece of our collective effort, and you'll see (beginning on page 20) that we had another banner year of outstanding new publications, many of which won awards (see page 12) or were featured in the media. We also announced several new series last year (see page 6), adding to our already illustrious program of book series (see page 34).

Our journals program continued its steady growth as we expanded the number of journals we support, but we also branched out to build the infrastructure to support more openly accessible journals being developed across the state (see page 10). We continued our efforts to extend our open access initiatives (see page 8), which will remove financial barriers to access our scholarship.

Meanwhile, our Longleaf Services subsidiary has been growing rapidly in overall volume—and in reputation—as a hub of innovation and efficiency.

Lastly, we're deeply grateful for the financial support we receive from many benefactors and supporters (see page 46). Last year we announced two significant new fundraising initiatives (see page 4), both of which will ensure that the Press launches into

The depth and breadth of the Press's development program reflect the complexity of our publishing program. From the unrestricted, expendable annual fund to restricted, endowed named funds, and various combinations in between, our fundraising is as dynamic as the advancing and evolving fields of study we publish and the ways in which we deliver content.

Because exceptional staff are essential to fulfilling the mission, the Press diligently and intentionally has been raising endowment funds for vital staff

positions for several years. The effort began with the creation of the Spangler Family Director position followed by the Wyndham Robertson Editorial Director position. Planning around the recent centennial identified four more positions as funding priorities. Two of these, the naming of the Frank Kenan Director of Editing, Design, and Production position and the current fundraising effort for the W. Hodding Carter III Editor position and accompanying Fund, are featured on pages 4–5. On the horizon are the completion of the Director of the Office of Scholarly Publishing Services (OSPS) position and the initiation of the Director of Marketing position.

Second Century Campaign Highlight: Newly Endowed Positions

The Press's 2022 centennial anniversary gave us the opportunity to celebrate 100 years of groundbreaking scholarship and to envision a second century even more distinguished than the first. The Press's Centennial Steering Committee and Advancement Council worked with the Press staff to define fundraising priorities that would carry the Press confidently into its second century, four of which involve endowing senior staff positions.

The Press's budget, where 70% of expenses are salary and benefits, reflects the reality that the professional staff is the Press's most valuable asset. Furthermore, superior publishing, as accomplished by UNC Press, is a multiyear process. Endowed positions not only recognize the importance of the person holding the position, but they ensure the stability of the publishing process as well. Creating a named endowed position can be a loving tribute, as emerged with two treasured friends of the Press in response to defined centennial priorities.

Betty P. Kenan

For those fortunate enough to have known her, Betty Kenan was a fairy godmother with a wonderful sense of fun and a delightfully sly wit. Betty's first gift to the Press helped to create an endowed fund to support books in African American studies, revealed to honoree John Hope Franklin at his surprise ninetieth

birthday party. Her steadfast generosity to the Press Club annual fund was sprinkled with more lively endeavors both humble and ambitious. Betty was one of the first to respond to the Press's first, and only, foray into crowdsource funding for Doug Orr and Fiona Ritchie's *Wayfaring Strangers* book—she loved singing mountain music—and she gave generously to honor cherished friends with the named Spangler Family Director and the Wyndham Robertson Editorial Director positions.

It is entirely fitting that Betty was the first to claim one of the four endowed-position priorities, the Director of Editing, Design, and Production (EDP). The Press is renowned for how it publishes as much as for what it publishes, and this position is the perfect marriage of art and business. Though I proposed naming it both for Betty and her late husband Frank in recognition of their support of education, the arts, and business innovations, Betty was insistent that it stand only in loving memory of him. Thus was born the Frank Kenan Director of Editing, Design, and Production.

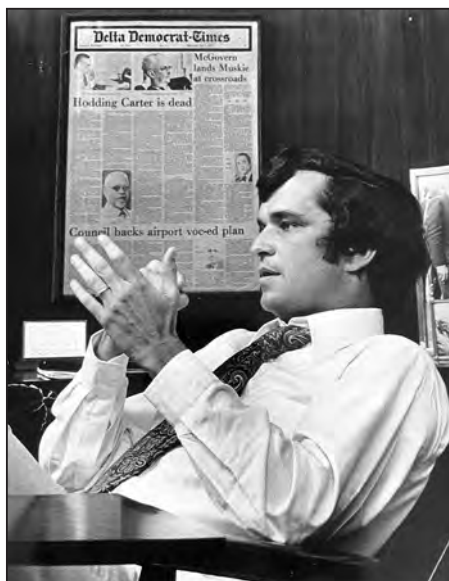
It was pure delight to introduce Betty to the inaugural Frank Kenan Director, Kim Bryant. As the Frank Kenan Director of EDP, Kim upholds the Press's enviable reputation for the beauty and artistry of its books while ensuring that technical and financial decisions make Press titles accessible to the greatest number of readers. "It was my great honor meeting Mrs. Kenan, a woman who has championed and promoted the Press for decades. Mrs. Kenan was a gift and I am grateful to be a part of her living legacy."

W. Hodding Carter III

Hodding Carter could command a room of hundreds while giving his attention to the one person in front of him. If I gave the rote answer of “fine” to Hodding’s inquiry about how I was doing, he would respond, “Come on, kid. How are you really doing?” And he meant it. Hodding generously supported the Press Club annual fund and the John Hope Franklin Fund in addition to several special initiatives. One was the creation of the Ferris and Ferris Imprint, an endowment initiative to which he not only personally gave but also actively raised funds for, helping the Press reach its \$2 million goal to publish trade books on subjects with roots in the American South. During many of these years, Hodding served on the Press’s Advancement Council and, while chair, served on the search committee that interviewed and recommended current Spangler Family Director John Sherer. In very real ways, Hodding directly influenced the direction of the Press’s second century.

Before Hodding’s death, I was able to share with him that dear friends wanted to name one of the endowed positions with an accompanying fund in his honor. In making the lead gift, these friends launched the endowed W. Hodding Carter III Editor position and W. Hodding Carter III Fund, and with the blessing of Hodding’s family, we continue to raise funds toward this \$2 million initiative. As 2023 came to a close, we surpassed \$1.7 million in gifts and pledges and have every expectation of successfully completing the initiative in the coming year.

The quality of Press titles, and thus the Press itself, is a direct reflection of the caliber of its editors, one of whom will now be the W. Hodding Carter III Editor. Editors are talent scouts for superior authors and managers of the peer review process, the hallmark of university press publishing, balancing these immediate demands with long-term strategic visioning to ensure that the Press remains on the forefront of evolving scholarship. Mirroring the structure of the Ferris and Ferris Imprint Fund, the W. Hodding Carter III Fund will give the Carter Editor a similar

tool to develop high-profile trade authors who can translate their scholarship around justice, politics, and civil rights into books that appeal to a global audience.

UNC Press was founded by people of extraordinary educational and civic vision, and over the decades, those with the means and inclination to invest in that vision have given the Press the ability to attain ever-higher levels of achievement. Whether gifts are from an individual like Betty or a collection of friends and family like those honoring Hodding, we are exceedingly grateful to all who invest in the promise and future of UNC Press.

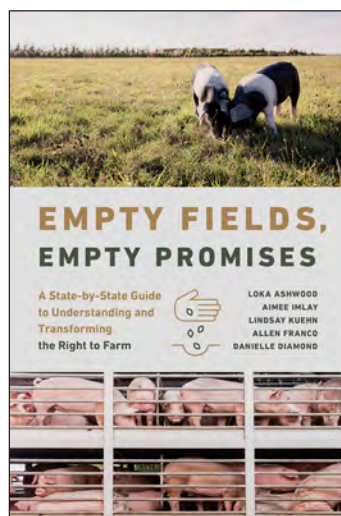
New Series from UNC Press

UNC Press's book series represent a special partnership between the Press's acquiring editors, scholarly series editors who are at the forefront of their respective fields, and authors whose work meaningfully advances the series mission. By partnering with series editors, the Press is able to strengthen its relationships and reputation within core fields and also provide a recognizable destination for new work that generally represents the leading edges of scholarly inquiry. A complete list of active series is on pages 34–37. New series are highlighted here.

In the spring of 2022, the UNC Press Board of Governors approved the Rural Studies Series (RSS) to join the Press's list of prestigious series. RSS was previously housed at West Virginia University Press and Penn State University Press and is edited by Conner Bailey and Jennifer Sherman. The series has long published a broad array of social science scholarship



and we are eager to revamp and bring it to larger and more diverse academic audiences. The first book in the series, *Empty Fields, Empty Promises: A State-by-State Guide to Understanding and Transforming the Right to Farm*, edited by Loka Ashwood, Aimee Imlay, Lindsay Kuehn, Allen Franco, and Danielle Diamond, came out in the fall of 2023.



In October of 2022, the board approved the Black Food Justice series, which focuses broadly on social science approaches to food insecurity in the American and Global South. The series, edited by Ashanté Reese and Hanna Garth, features scholarship that explores how Blackness can be theorized and understood through the study of food and how the meaning of food itself is challenged and transformed when analyzed through theoretical frameworks grounded in Black thought and liberation. As ethnographers



of everyday life who have been working as both food justice scholars and activists in the United States and beyond for more than a decade each, the series editors shaped this series with the intention to name, define, and create future visions for Black food justice scholarship that can have

material implications for protecting, nourishing, and cherishing Black life. We have published two books in the series thus far: *Food Power Politics: The Food Story of the Mississippi Civil Rights Movement*, by Bobby Smith II, and *Beyond the Kitchen Table: Black Women and Global Food Systems*, edited by Priscilla McCutcheon, Latrice E. Best, and Theresa Rajack-Talley.

In April 2023 the board also approved the new series *MP! Momentary Futures in Black Studies*, edited by L. H. Stallings, chair of Georgetown University's

Department of African American Studies. Venturing into futurity and speculation, the series focuses on Black thought experiences, challenges the parameters of current theories, advances new ideas about knowledge production, and escapes finite approaches to the field of Black studies. With a particular interest in manuscripts clearly conceived, written in accessible language, and of a reasonable length (generally under 100,000 words), the series will

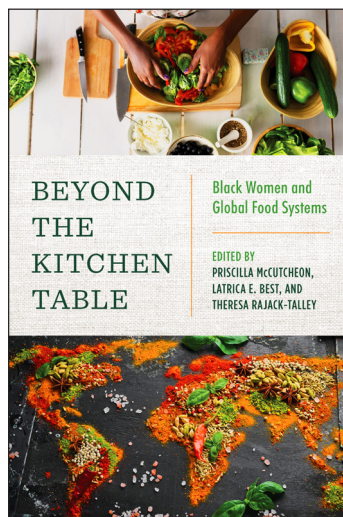


primarily publish monographs while being open to publishing an occasional edited collection or creative nonfiction project, as well as works representing genre-blending innovations that disrupt and defy disciplinarity and temporality. Stallings is especially interested in books that privilege inventive interdisciplinary scholarship and incorporate rigorous research and storytelling. The first book in the series, J Finley's *Sass: Black Women's Humor and Humanity*, will be published in fall 2024.

In November the board approved the Press's first-ever series to feature writing about music. The *American Music: New Roots* series will feature books by journalists, music critics, scholars, and musicians themselves, aiming to expand and challenge the way we think about American roots music genres, traditions, performers, and their ever-expanding contributions. Books in the series will not only bring new perspectives on familiar roots traditions like jazz, the blues, country, and folk music but also offer new

and more diverse ways to consider where the roots of today's American music lie, what stories are told about them, and who does the telling. Series editor David Menconi is an accomplished arts and culture journalist and editor who has worked with the Press to publish two books: *Step It Up and Go: The Story of North Carolina Popular Music, from Blind Boy Fuller and Doc Watson to Nina Simone and Superchunk* (2020) and *Oh, Didn't They Ramble: Rounder Records and the Transformation of American Roots Music* (2023). The first published books in the series are expected in late 2024.

Also in November, the board approved a new history series called *InterConnections: The Global Twentieth Century*, which will publish books on international and cross-regional histories grounded in multiarchival, multilingual, and multisited research. The series traces its roots to the Press's acclaimed *New Cold War Histories* series (no longer active), and we seek to expand it by showcasing work that transcends conventional geographic, temporal, and



disciplinary borders, offering fresh and original perspectives on the making of the contemporary world. Series editors Julia F. Irwin, Christopher McKnight Nichols, and Jayita Sarkar are interested in archive-based historical scholarship with a global framework that engages with key themes of twentieth-century worldmaking. The first published books in the series are expected in 2025.

New Developments in Open Access

Open-access (OA) scholarship is digital, online, free of charge, and free of most copyright and licensing restrictions.

At UNC Press, the broad dissemination of scholarship is core to our mission, so we enthusiastically share the vision of many OA advocates. Despite the opportunities afforded by digital formats, most traditional academic publishing models reinforce networks of privilege where scholars and students at well-resourced universities can read our books and journals, but anyone outside that network must overcome significant financial obstacles to access our publications. Expanding access must be a primary goal for any organization that claims to espouse progressive views of social justice and equity.

But we also must emphasize that the creation and marketing of high-quality scholarship requires significant investments in time and money from the Press and from our authors. Without a major transformation in how humanities publishing is funded, we may never be able to align with the most ambitious versions of OA. Currently less than 8% of our publishing expenses are funded through stipends or institutional/state subsidies.

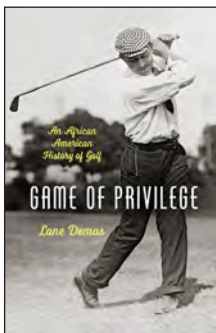
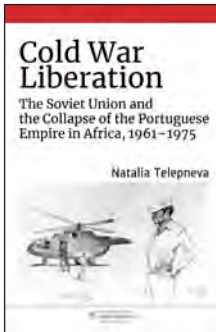
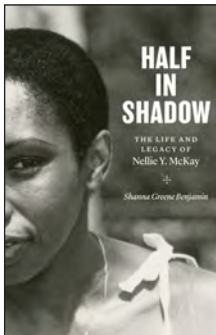
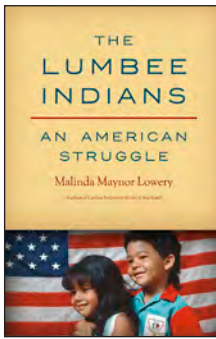
UNC Press has been a leader in OA among university presses. We have actively participated in numerous programs, including two NEH/Mellon Open Book grants, the NEH Fellowship of the Open Book Program, TOME (Toward an Open Monograph Ecosystem), Knowledge Unlatched, as well as a number of open educational resources being developed within the UNC System. We were the primary investigator in the Mellon Foundation-funded Sustainable History Monograph Pilot (SHMP). We are implementing a use case of the new Book Analytics Dashboard Project. This pilot program will allow us to measure the exponential increases in usage we see with open editions. We will use this data to demonstrate impact and value for our OA publications.

Strategies for Open Access

OA looks very different depending on the form and discipline of scholarship. As a result, we have developed different strategies to move us toward more open scholarship.

- **Scholarly monographs:** The monograph is the lifeblood of university press scholarship. It is how humanities research is advanced and preserved. While we have participated in numerous open monographs experiments and seen the exponential increases in usage of open works, we have yet to see a sustainable model for scaling OA monographs. Our current priority is the newly announced Path to Open pilot, developed by UNC Press, the University of Michigan Press, and the American Council of Learned Societies, and being operationalized by JSTOR. Path to Open is an imperfect solution which necessitates paywalls to access for three years before a book becomes completely open. But it has the potential to open far more new university press monographs than any other program, and it does so without any external or grant funding.

- **Journals:** Academic journals are arguably the most dysfunctional channel of all scholarly publishing. Dominated by global commercial conglomerates, the prevailing business model derives profits by creating artificial scarcity and delimiting access to research. UNC Press, through its Longleaf Services subsidiary, has been a participant in the Arcadia-funded Next



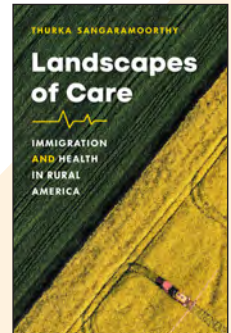
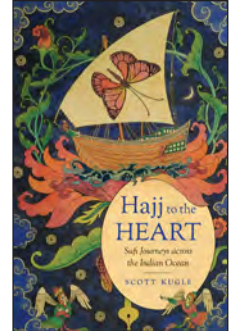
Generation Library Publishing pilot for three years. We are now embarking on our own initiative to implement the NGLP open-source tools within the UNC System. This use case—called the Partnership for Open Publishing—will advance humanities and social science scholarship originating across the seventeen campus system while also becoming an extensible business model to support a wide variety of potential future implementations. We have been working with faculty at UNC Chapel Hill in the newly created Academic Research Community Alliance, which is a community of like-minded scholars supportive of nonprofit, altruistic, exceptional scholarly publishing alternatives to standard publishing models. Additionally, the Press is participating in the recently launched Subscribe to Open program from Project MUSE. This program aims to eliminate financial barriers for both readers and authors and leverages the enormous body of scholarship on the MUSE platform.

• **Open Educational Resources (OER):** An OER is essentially an open access textbook. Through our Office of Scholarly Publishing Services, UNC Press has already facilitated the publication of numerous open textbooks. We continue to explore partnerships with UNC System scholars to develop, publish, and promote these high-quality volumes that save students in North Carolina thousands of dollars.

The Future of OA and UNC Press

The landscape around OA is rapidly shifting. We need to be prepared to respond to mandates like Plan S and its Rights Retention Strategy as well as the White House's Office of Science and Technology's "Nelson Memo." The latter will require taxpayer-supported research to be immediately available to the American public at no cost.

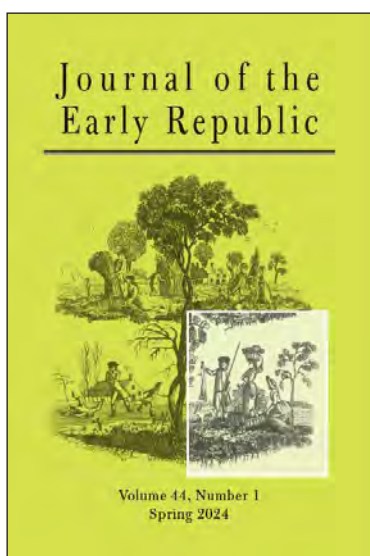
UNC Press was founded a century ago to solve the publishing challenges of the early twentieth century. Our ambition now is to address today's challenges and opportunities to develop new, low-friction models of open access publishing where usage increases exponentially while reducing financial burdens among all the participants in the ecosystem: scholars, societies, presses, libraries, and readers.



New in NC Journals

Journals Program Expansion: Growing the List and Developing a Partnership for Open Publishing

Exciting developments are underway for journals at the University of North Carolina Press, where the number of titles in the program has jumped in the past five years. In 2017, we added the *North Carolina Literary Review*; in 2019, we brought on *The Latin Americanist* and *The Greensboro Review*; in 2020, the architectural history annual *Arris* joined the list; in 2021, the interdisciplinary, interreligious quarterly *CrossCurrents* came to the Press from a large commercial publisher. Beginning in 2024, we will publish two more quarterlies: the *Journal of the Early Republic* and the *North Carolina Historical Review*. The Press currently provides



fifteen journal partners services ranging from editorial, production, and design to marketing, membership management, and subscription fulfillment.

This year, we embark on initiatives that will continue to grow the program along two avenues.

First, we will increase the scale of the program. We are devising a strategy to add journals steadily and sustainably, focusing on titles conversant with the strengths of our books program, including US history, American studies, African American history, Black history, religion, and sociology. As we increase the size of our list, we will also naturally seek to enhance the kinds of services we can provide our journal partners.

Second, in an initiative called the Partnership for Open Publishing (POP), we are building on open-source software that was developed during the Next Generation Library Publishing pilot (2019–22) to develop a new, low-friction model of open access journal publishing where usage increases exponentially while financial burdens decrease for all the participants in the ecosystem: scholars, societies, presses, libraries, and readers. As it builds stronger bonds between the Press and its institutional community in the near term, POP will also ultimately become an extensible business model to support a wide variety of future implementations outside the UNC System.

To facilitate these ambitious initiatives, the Press has invested in a new position, and this past summer, we hired Stacy Lavin to fill the role of Journals Manager. Stacy comes to the Press with more than a decade of experience with humanities and social sciences journals. Her expertise lies in peer review, editorial, and production workflows and journal partner management. In her previous position at Duke University Press, she led an initiative to streamline editing, design, and production workflows and transitioned over half of the program's sixty-plus journals to a new online peer-review platform. The perspective she brings from establishing efficient processes within a large-scale journals program will be key as the Press seeks to accumulate journal partners sustainably and launches POP.

Acquisition Spotlight: *Journal of the Early Republic*

The Press's acquisition of the *Journal of the Early Republic* represents a new constellation of important partnerships. The Society for the History of the Early Republic (SHEAR), which owns the journal, recently relocated to a new institutional home within the Omohundro Institute of Early American History and Culture (OI), which is in turn sponsored by William & Mary in Williamsburg, Virginia. The Press has partnered with the OI's editorial team for over fifty years to produce and publish award-winning books in the field of early American history. Now it will also publish one of its journals.



For SHEAR President-Elect Paul Erickson, Director of the Clements Library at the University of Michigan, Ann Arbor, the simultaneous move to the Press and the OI is a double boon: "SHEAR is tremendously excited about its new partnership with the Omohundro Institute and UNC Press. The *Journal of the Early Republic* is the journal of record for the study of US history from 1776 to 1861, and we could not be

happier to have it be in company with the other journals published by UNCP. Likewise, our partnership with the OI will allow both organizations to streamline operations and capitalize on shared interests to better promote the study of early America."



Catherine Kelly, OI Executive Director since 2022 and Editor of Books since 2018, points out that SHEAR's move will inaugurate an important historical consortium: "We are delighted to welcome the Society for Historians of the Early Republic to a new home at the OI as founding members of the Virginia Consortium of Early American History, which will forge sustained connections among the state's leading research centers. SHEAR—an organization that has facilitated field-defining, pathbreaking work about the early US republic via its conferences and the JER—will be a crucial partner as we look toward the future."

Awards

The University of North Carolina Press has a long history of publishing award-winning books that receive prizes ranging from scholarly awards to prestigious, public-facing ones. This past year, more than forty of our books were recognized with over seventy honors and distinctions. A complete list of awards is on pages 30–33. Here are a few highlights:

Our authors took home three wins and two honorable mentions from the Organization of American Historians, the largest professional society dedicated to US history:

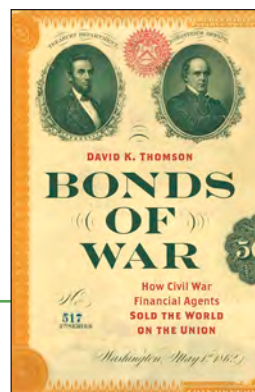
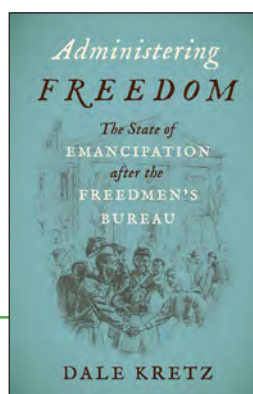


- Christina Greene's *Free Joan Little* won the 2023 Liberty Legacy Foundation Award and received an honorable mention for the 2023 Darlene Clark Hine Award.
- Dale Kretz's *Administering Freedom* won the 2023 Civil War and Reconstruction Book Award.
- David K. Thomson's *Bonds of War* received an honorable mention for the 2023 Civil War and Reconstruction Book Award.
- Michael John Witgen's *Seeing Red* (Omohundro Institute of Early American History and Culture) won the 2023 James A. Rawley Prize.

Psyche A. Williams-Forsen's *Eating While Black* won the 2023 James Beard Foundation Book Award in a new category, Food Issues and Advocacy. The James Beard Awards are among the nation's most prestigious honors recognizing leaders in the culinary and food media industries and those in the broader food systems. This is our second consecutive year winning a James Beard Award—Adrian Miller's *Black Smoke* (Ferris and Ferris Books) won the 2022 award in the Reference, History, and Scholarship category.

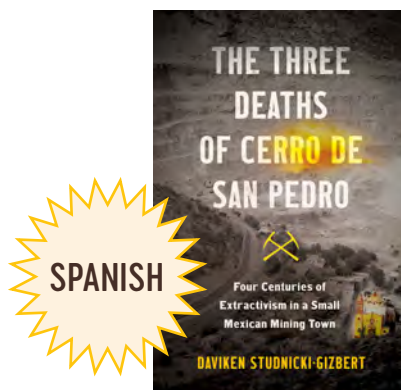


And perhaps most notably, *Seeing Red* was a 2023 Pulitzer Prize in History Finalist. The Pulitzer is one of the world's most distinguished literary awards, and it is always gratifying when one of the Press's authors is recognized by Pulitzer judges. Our last Pulitzer Prize Finalist was Keeanga-Yamahtta Taylor's *Race for Profit*, which received the honor in 2020.

Although our books are available internationally and many scholars research and read in English, we work hard to license as many of our titles as possible for translation. A complete list of subrights is on pages 40–41.

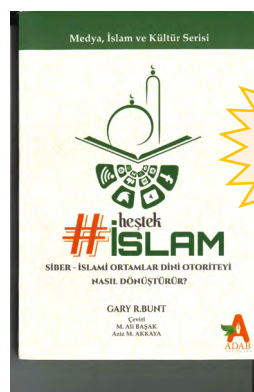


The Three Deaths of Cerro de San Pedro: Four Centuries of Extractivism in a Small Mexican Mining Town by Daviken Studnicki-Gizbert was licensed by one of Mexico's most prestigious publishers, Fondo de Cultura Economica. This is a history of precious-metals extractivism as lived in a small gold- and silver-mining district in Mexico from the time of the Spanish conquest to the present. The Spanish edition, which will be published in early 2025, will offer an important perspective to environmental justice conflicts around extraction in Latin America.

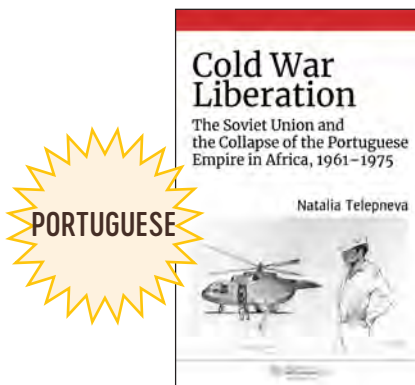


A Vietnamese edition of Michitake Aso's *Rubber and the Making of Vietnam: An Ecological History, 1897–1975* was published in August by Ho Chi Minh General Publishing House. The award-winning book, which was published in the Flows, Migrations, and Exchanges series, shows how rubber production has wrought monumental changes worldwide.

A Turkish edition of Gary Bunt's *Hashtag Islam: How Cyber-Islamic Environments Are Transforming Religious Authority* was published in November by ADAB Yayınları. The book explores the diverse and surprising ways digital technology is shaping how Muslims across vast territories relate to religious authorities in fulfilling spiritual, mystical, and legalistic agendas.



Natalia Telepneva's *Cold War Liberation: The Soviet Union and the Collapse of the Portuguese Empire in Africa, 1961–1975* was licensed to Imprensa de História Contemporânea for Portuguese translation. The book examines the African revolutionaries who led armed struggles in three Portuguese colonies—Angola, Mozambique, and Guinea-Bissau—and their liaisons in Moscow, Prague, East Berlin, and Sofia.

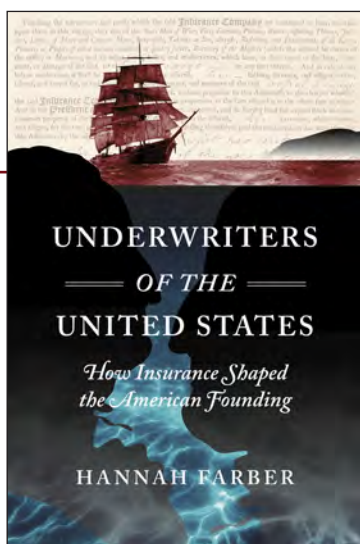




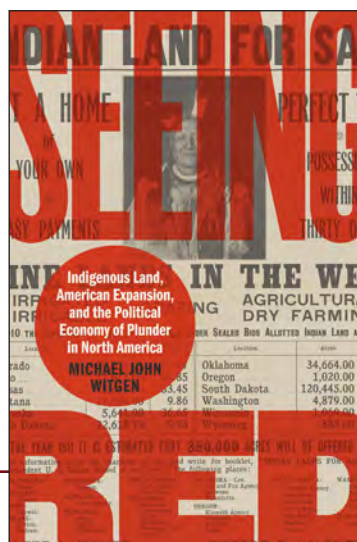
Established in 1943, the Omohundro Institute of Early American History and Culture (OI) is the oldest organization in the United States exclusively dedicated to the scholars and scholarship of early America broadly understood, encompassing the period from 1450 to 1820 and including related developments in Africa, the British Isles, the Caribbean, Europe, and Latin America. An independent research organization located in Williamsburg, Virginia, the OI is co-sponsored by William & Mary, home of the nation's

THE MISSION OF OSPS is to serve the University of North Carolina System by providing access to a range of sustainable, mission-driven publishing models and solutions. Leveraging the expertise and scale of UNC Press and its nonprofit subsidiary, Longleaf Services, OSPS collaborates with libraries, research centers, institutes, and departments to lower the cost of producing and disseminating quality educational and scholarly publications. OSPS also selectively works with other nonprofit institutions seeking to publish scholarly or general-interest work that will benefit the people of North Carolina.

OSPS Project Highlight: Some of our partners have ongoing publishing programs such as series and imprints that require a sustained level of engagement. The Department of World Languages and Cultures at NC State University houses Editorial A Contracorriente, publisher of an open access journal and monographs in Latin American studies. Scholars in this field face a challenging publishing environment, particularly those outside of North America writing in Spanish. Under the direction of Greg Dawes, Distinguished Professor, Editorial A Contracorriente has published more than fifty monographs since 2012, including five in 2023, providing a valuable publishing outlet for scholars working in literary studies, cultural studies, and history. Ross Publishing Grants

Born out of the Press's desire to thank then president Thomas W. Ross for providing start-up funding to launch OSPS, many friends came together to create the Thomas W. Ross Fund. While not all OSPS projects need support, the Ross Fund provides invaluable small grants to those that do, helping departments, centers, and libraries of the UNC System leverage their resources to publish scholarly material generated on their campuses that might otherwise go unpublished. The UNC Charlotte Gerontology Program in partnership with UNC Wilmington will reissue *The Delany Sisters Reach High*, a children's book used in a toolkit to help teach preschool through second graders about aging.

The *Cold Mountain Review* at Appalachian State University received a grant to help with publish-

ing initiatives to celebrate its fiftieth anniversary, including the publication of *Night Swimming*, a poetry chapbook.

East Carolina University's Sport and Community Development Lab received funds to publish a textbook focused on community building and the importance of social connections gained through sport.

In March, OSPS launched a new distribution relationship with the Library of Congress for its Collection Close-Ups series. The series will feature short, affordable, and accessible books that bring the library's collections to life through historical anecdotes, colorful images, descriptive captions, and sidebars. The first two books, *The Joy of Looking* and *American Feast*, were published in March, highlighting the library's extensive holdings in the areas of photography and food.

We are pleased to extend our partnership with the Library of Congress to support their Exhibit Companion Series. The first book will be *Collecting Memories: Treasures from the Library of Congress* for an exhibit that will open the new David M. Rubenstein Treasures Gallery in June 2024. *Collecting Memories* explores the ways people have preserved their history, culture, and personal recollections in a variety of artifacts.

A second book, *Two Georges: Parallel Lives in an Age of Revolution*, is in the works for a 2025 exhibit that will recontextualize the life of George Washington and paint a fuller picture of King George III.

Sources of Income

The chart below shows the many sources of income here at UNC Press and how the diversity of these income streams insulates us from the short-term fluctuations in any one part of the operation. Within these different streams of income are three general categories: sales revenues, state support, and development. The year 2023 saw a return to our more traditional revenue patterns after two years of COVID fluctuations.

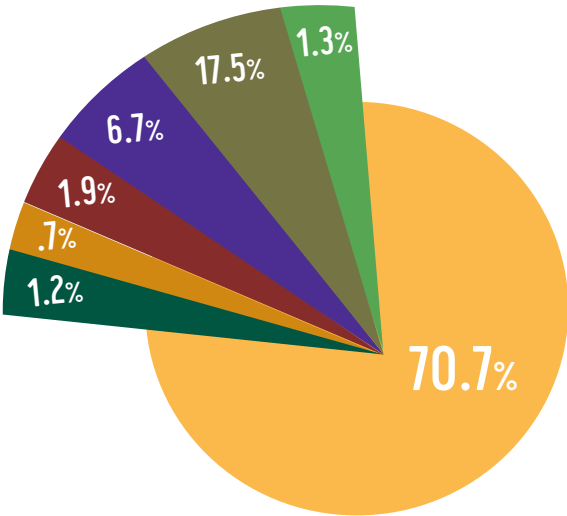
The Press operates primarily as a cost-recovery enterprise, with revenues coming from a variety of

business units. This includes not only sales of books and journals but also income from subsidiary rights and publishing services activities. These proceeds usually amount to about 71% of our total income.

The second major source of income is the fixed support we receive through the state and university system. These funds covered 7% of our revenues.

Finally, we have a robust development program that includes our endowment and annual giving initiatives. These efforts cover around 19% of our income.

Defined Initiatives for the Press's Second Century

COMMITTED

UNC American History Fund. UNC Press has a distinguished reputation in fields that comprise American history, including African American and race relations studies. As John Hope Franklin, whose first book the Press published in 1944, stated, "African American history is American history." This fund will build on the Press's pioneering publications, signaling its continued commitment to be at the forefront of new, crossdisciplinary approaches to American history with greater breadth of author experiences. An anonymous donor has generously endowed this \$1 million initiative to support cultivating ideas, attracting superior authors, and raising awareness for new areas of study in American history.

Frank Kenan Director of Editing, Design, and Production (EDP). The Frank Kenan Director supervises in-house manuscript editors, book designers, and production managers, as well as freelancers responsible for copyediting, proofreading, indexing, cover and interior design, typesetting, and manufacturing. Betty Kenan has generously endowed this \$1 million named position in memory of her late husband to support critical efficiencies the Frank Kenan Director manages throughout the manuscript-to-book process, efficiencies that will grow in importance as the Press increases its number of published titles.

IN PROCESS

W. Hodding Carter III Editor and Fund. The quality of Press titles, and thus the Press itself, is a direct reflection of the caliber of its editors. As talent scouts for superior authors and as managers of the peer review process, the hallmark of university press publishing, acquisition editors are paramount. Editors balance competing priorities, from immediate management of the publishing pipeline to long-term strategic visioning. A \$1 million endowment will defray expenses for this position vital to expanding opportunities for authors of impactful scholarship.

An accompanying \$1 million endowed Acquisition Fund will support Press editors' nurturing of authors with distinct voices to develop books for trade audiences, an increasingly competitive area of scholarly publishing. The immediate success of the Ferris and Ferris Imprint demonstrates the value of developing authors who can translate their scholarship into books that appeal to the general public. Publishing trade titles will have the additional benefit of strengthening the fiscal health of the Press, supporting the publication of more mission-driven scholarly titles.

Named Office of Scholarly Publishing Services (OSPS) Director. UNC Press launched OSPS in 2015 to provide affordable publishing expertise to all UNC campus libraries and academic departments. With more than 100 publications to date, OSPS has directly furthered faculty teaching with greatly improved scholarly content and benefited students with low- and no-cost access to that content. A \$1 million endowment to create a named Director of OSPS will ensure resources to support deeper exploration and creation of scaled publishing solutions.

FORTHCOMING

Named Marketing Director. The director of marketing oversees marketing and sales for all Press books and is responsible for sales budgeting and forecasting, distributing metadata to vendor and industry partners, and contributing to book acquisition decisions and list building. The marketing director unequivocally influences accessibility and affordability of Press titles through strengthening relationships with existing readers and reaching out to new audiences, determining placement and formats for titles, and setting the sales price for each title. A \$1 million endowment will defray expenses for this position critical for connecting authors and readers.

Illustration Fund. A significant number of Press titles, whether traditional print or digital versions, include art, illustrations, and maps, all of which enhance the presentation and understanding of the work. A \$250,000 endowment will defray the more than \$35,000 expended each year to secure permissions for cover art, illustrations, and commissioned maps.

Second Century Innovation Fund. UNC Press enjoys a reputation for innovating and taking calculated risks that not only benefit society but also advance the Press and the publishing industry. Examples include *The Encyclopedia of Southern Culture* and *A New History of the American South*, as well as the creation and launch of Longleaf Services and the Office of Scholarly Publishing Services. A \$2 million endowment will give the Press resources to strategically invest in launching innovative projects and entrepreneurial ventures.

Named Publishing Fellowship. Fellowships enable outstanding college graduates to enrich their career paths and create new opportunities for advancement. This Named Publishing Fellowship will allow students not traditionally represented in the industry to experience publishing in its fullness. The \$1 million endowed fellowship will be a paid, two-year position at the Press, with preference for a recent UNC system institution graduate from an underrepresented demographic.

EXISTING NAMED ENDOWMENT FUNDS

Endowments provide vital stability for multiyear publishing projects through their predictable streams of income. Gifts of any amount may be made to existing named endowments. Gifts of \$150,000 or more may be made to create new named funds, and gifts of \$1,000,000 or more may be made to create new named positions. The Press's endowment is professionally managed by the UNC Management Company, with the spending policy set by the Press's Board of Governors.
