Living and Working in the Shadow of the Pandemic

What will future generations want to know about how UNC Press endured this year, a year when we all felt an unprecedented amalgam of panic, stress, and fear but also resilience, success, and even triumph? Publishing is one of the few industries where the abrupt transition to remote work was not completely disruptive, and, indeed, we took advantage of the moment to address some much-needed changes in how we use technology in our daily work. In some ways, we have built a more inclusive and participatory Press by relying heavily on tools to keep us connected. Additionally, books became an essential commodity since they offered one way for people to occupy their time in the safety and solitude of their homes. At the same time, our books on the history of race and social justice became integrated into this summer's protest movements. Our authors were frequently on the forefront of these national conversations, and books that had previously found audiences mostly in the academy were speaking to a much broader public.

When the pandemic first exploded in the very early spring, we were approached by a number of our digital platform partners asking us to remove the paywalls to our eBooks. Thousands of students, faculty, libraries, and scholars had lost access to their physical and digital book collections. But in March, our sales were down 50 percent. Could we afford to stop collecting money for digital access? We weren't sure, but we also knew that as a mission-driven member of the academic community that was under incredible stress, we needed to do our best to contribute. We offered free access to our collections for three months, and a fascinating thing happened. First, our digital usage increased as much as tenfold. And second, our print sales rebounded—and actually set some sales records for us during the summer. It was clear that people urgently needed access to our scholarship, validating how important and useful those books were. We also learned that expanding digital access is not always a threat to print revenue.

There is no going back to the pre-pandemic way of doing things. We've done some restructuring (for example, combining our editorial, design, and production groups into one department and shifting our marketing emphasis to true digital-first engage-

ments), and we will almost certainly have hybrid work arrangements in the future where employees work partially in the office and partially from home. But there's no doubt we've missed the powerful dynamic of in-person meetings and day-to-day interactions. Publishing is collaborative and iterative, and we do it better when we impulsively generate and debate ideas. We're all looking forward to the day when we can reintegrate those moments into our work.

Sales and Financial Results

This report provides a summary of our financial results (see page 7). After an initial precipitous and worrying decline in the spring, we successfully applied for and received a Payroll Protection Program loan (which later became a grant) to support the Press and Longleaf during an unstable time. We also were grateful to receive an NEH CARES grant. With those resources in place and the assurance that we would be able to maintain our full staffing levels, we were able to rebound with a very strong summer and fall. At the same time, there were no pay increases for staff, and the funds we typically earmark for the expenses associated with travel and conferences went unspent. It was a year of necessary austerity, but those sacrifices helped ensure that the Press would endure through this historically challenging time.

Diversity, Equity, and Inclusion Work (DEI)

While the nation wrestled with issues of race and justice, we have continued to look introspectively at the publishing industry as well as our own organization. Our books and authors represent a diverse and inclusive cross-section of our state and country, but

publishing itself remains a very white and exclusionary industry. We accomplished a lot this year in our continuing efforts to address this legacy of inequity: we created a mentorship program; expanded our open access (OA) publishing work to improve accessibility to our books; reviewed our recruiting and hiring practices; drafted a new Code of Conduct; and generally tried to integrate DEI concepts into our daily work. I personally have participated in more than half a dozen training sessions to challenge my own perspectives and practices. This will be a long-term project, but our hiring over the past two years has been by far the most diverse in the 100-year history of the Press.

The Books

We also know that one of the biggest reasons our books sold well this year is because they are pretty darn good books. The list of our publications (see pages 18–29) reflects the long-term plans we've made to grow our title count while also publishing more books that have broad public appeal. The editorial direc-(photo: Donn Young) tor's letter provides the key highlights (see page 14), but our scholarly titles continue to win almost every award on offer (see page 30–32), including, once again, the Bancroft Prize and the Frederick Douglass Prize. One of our titles was even nominated for the Pulitzer Prize. We had books reviewed in the New York Times and authors interviewed on National Public Radio.

Passings and Transitions

In a year already sadly overflowing with pain and loss, we want to remember our good fortune for having worked with the late authors Jenny Tone-Pa-Hote and Randall Kenan. The Press also lost a wonderful champion in Rollie Tillman and a devoted former board member, Barbara Moran.

In more salubrious tran-

sitions, we celebrated the retirements of Chuck Grench (executive editor), Robbie Dircks (associate director, chief financial officer, and president of Longleaf

Services), Gina Mahalek (publicity director), Stephanie Wenzel (assistant managing editor), and Suzi Waters (journals coordinator) (see page 5). Together, they contributed almost 100 years of service to the Press.

We're incredibly grateful for their work, and we wish them the very best in their well-deserved retirements.

So many changes have also meant a number of promotions and hires, including in some key leadership positions. Jami Clay was promoted to director of finance and administra-

tion. Veronica Fuller was named accounting associate. Kim Bryant was promoted to director of the editorial, design, and production department. Clay Farr was promoted to chief executive officer of Longleaf Services. John McLeod was named chief operating officer.

In the marketing department, Peter Perez was hired as the director of public relations/communications and Sonya Bonczek was hired as publicity director. And in our acquisitions department, Dylan White and Andrew Winters were each promoted to associate editor,

making them the first people of color in the Press's history to be acquiring books—a long overdue milestone for the Press but one that we're still very proud of.

Longleaf Services

Longleaf continues to play a vital role for an evergrowing number of university presses (see pages 36-37). They heroically maintained uninterrupted service even during the deepest depths of the pandemic and helped a number of our presses rebound quickly to achieve record sales this year. Longleaf has also become a leader in publishing innovation, participating in two major grant-funded initiatives aimed at transforming scholarly book and journal publishing.

Office of Scholarly Publishing Services (OSPS)

OSPS remains focused on supporting publishing initiatives that originate within the University of North Carolina System (see pages 38-41). We are proud of the steady increase in these organic efforts and look forward to ensuring that the Press remains a vital partner to every campus throughout the state.

Thank You to Our Many Benefactors

We are deeply grateful for the enduring support we've received from our many benefactors (see pages 42-51). The years of generosity of these individuals helped create a safety net and a level of confidence—even in the darkest days of the pandemic—that we would navigate our way out of this uniquely challenging time. The Future

On a personal level, it was as active a year as any. I served on the Association of University Presses Open Access Task Force. I was on the advisory board for a Mellon-funded pilot to support a data trust for open access usage. I served on the boards of the Educopia Foundation and Orange Literacy. I remain on the UNC-Chapel Hill Copyright Committee, and I was asked to join a newly formed management advisory committee for our colleagues at Duke University Press. I was grateful to remain deeply engaged in this work, as it helped compensate for the physical isolation required by the public health crisis.

At this writing, we are trying to imagine what work will look like in a post-pandemic world. I'm incredibly proud of the innovative ideas being generated by the staff about creating a more inclusive, efficient, and forward-thinking UNC Press. In its nearly 100-year history, this institution has survived the Depression, a world war, countless boom and bust cycles, and even a fire that burned our building to the ground. And now we can say we've survived a global pandemic. Endurance is apparently in our DNA.

To be recognized as the nation's premier public university press while remaining a progressive force in the state and region.


About the Press

The University of North Carolina Press, a nonprofit publisher of both scholarly and general-interest books and journals, operates simultaneously in a business environment and in the world of scholarship and ideas. The Press advances the university's triple mission of teaching, research, and public service by publishing first-rate books and journals for students, scholars, and general readers. The Press has earned a distinguished reputation by publishing excellent work from the nation's leading scholars, writers, and

intellectuals and by presenting that work effectively to wide-ranging audiences.

Established in 1922, UNC Press was the first university press in the South and one of the first in the nation. Our regional publishing program—aimed at general readers and offering engaging, authoritative work on all aspects of the region's history and culture, its natural and built environment, and its music, food, literature, geography, and plant and animal life—has been widely adopted in other parts of the country. Over the years, Press books have won hundreds of prestigious awards including the Pulitzer Prize and the National Book Award and those of many national scholarly societies. Today, the imprint of UNC Press is recognized worldwide as a mark of publishing excellence—both for what we publish and for how we publish. Because of our respected authors who rely on the Press to connect readers with important ideas, the name of the university is carried on Press books and journals across the country and around the globe, in both print and digital formats.

Sources of Income


The chart below shows the many sources of income here at UNC Press and how the diversity of these income streams insulates us from short-term fluctuations in any one part of the operation. Within these different streams of income, there are three general categories.

The Press operates primarily as a cost-recovery enterprise with proceeds coming from a variety of business units. These proceeds cover approximately 72% of our expenses. The bulk of that comes from the sales of books and journals (69%), with the balance coming through subsidiary rights and publishing services activities (3%).

The second category is the support we receive through the state and university system, which accounts for 7% of our income. This year the Press successfully applied for a Payroll Protection Plan grant, which provided another 7% of our income.

Finally, we have a robust development program that supports an endowment and annual giving initiatives, generating the final 14%.

Board of Governors

The Board of Governors of the UNC Press is a body of nineteen members, fifteen of whom are elected by the Board of Governors of the University of North Carolina and four of whom serve ex officio, charged with the responsibility of directing the affairs of the Press. This includes establishing and monitoring all policies and programs for the maintenance, operation, and improvement of the Press, including its publishing policies and projects and its budget and financial policies.

A member's responsibilities include attending board meetings; reviewing and voting on approval of monographs, series, and other publishing projects of the Press; consulting with and advising the director of the Press on matters of financial and publishing policy and strategy; and serving as needed on ad hoc or standing committees.



Dear Friends:

Strange as it may sound, as I reflect on 2020, I cannot recall a more gratifying year in my career at UNC Press. Yes, the year will always be remembered for the profound human and other costs of the COVID pandemic, the continued outrages of racism that plagued the United States, and the nation's unprecedented political upheavals. But I will also remember 2020 for the extraordinary sense that the books we helped develop. evaluate, and publish truly mattered. Works of translational scholarship like Keeanga-Yamahtta Taylor's Race for Profit and William Darity and Kirsten Mullen's From Here to Equality found their way into the explanatory journalism of major publications, into the hands of literally thousands of readers, and into the daily conversations of those seeking reliable, peer-reviewed context for urgent debates of the moment. Grace Elizabeth Hale's Cool Town, the inaugural book in our Ferris & Ferris imprint, earned rave reviews in the New York Times Book Review and from a range of music and arts critics. Meanwhile, too many Press authors to count stepped into the public arena with opinion essays drawing connections between their books and matters of local, national, and global concern. We were delighted when the New York Times's Brent Staples tweeted on November 15, 2020, "The University of North Carolina Press is killing it - 24/7."

Though the acquisitions team was prevented from engaging in our normal schedule of conference travel and campus visits, our newfound familiarity with Zoom and similar platforms helped empower members of our editorial team to share their expertise and advice about the publishing process far and wide. Over a two-day period in early June, the acquisitions team served more than 300 would-be authors with a series of online workshops, social media "office hours," and similar outreach; many more similar workshops and mentoring sessions have followed. While some contacts we make at such events might lead to a future submission of a proposal or manuscript, we are embracing the value of such outreach as a public good. On several occasions, team members also offered similar service to the university press community, participating in online sessions for the virtual annual meeting of the Association of University Presses and other sessions geared toward developing the next generation of scholarly publishing professionals. In these and myriad other ways, I look at what our team and our colleagues have accomplished despite significant challenges and see powerful evidence of high-impact publishing.

In 2020 we also created a strong foundation for the future growth and development of the Press's book list. Though in April we marked the retirement of our beloved colleague Executive Editor Chuck Grench, the transition allowed us to reorient and reorganize our staff into a new series of working groups. The most exciting dimension of this reorganization was the promotions of Andrew Winters and Dylan White. As associate editors. Andrew and Dylan are the first BIPOC acquiring editors in UNC Press's history, and they have quickly begun to help us expand our manuscript acquisitions in existing list areas while also charting a course into new social science and humanities subfields. Andrew is bringing new energy and a range of broader interests to our history list, working closely with Debbie Gershenowitz and Brandon Proia. Dylan has joined Lucas Church in another working group, and together they are expanding our lists in critical race and ethnic studies, sociology, and anthropology. Lucas and Cate Hodorowicz are leading a working group to chart another list expansion focused on the genre of creative nonfiction. Finally, acquisitions assistant Andreina Fernandez joined us in the fall, becoming the tenth full-time member of our editorial staff. Andreina comes to us with a graduate degree in women's, gender, and sexuality studies and a concentration in Latin American and Caribbean studies; she is supporting the work of the department as a whole as well as the list development work of Executive Editor Elaine Maisner. With these investments, we anticipate increasing our title output from 110 books a year to 130 books a year by 2023. Over the last four months of 2020, our team worked on a strategic review and planning process that will help guide this growth strategy.

It is impossible to overstate the sense of honor and pride I feel in working with such an accomplished, committed group of colleagues. I likewise cannot offer enough gratitude for the enduring support of the community of thinkers, writers, and readers that surrounds us and makes our work possible. This year more than ever, I am aware of all that is invested in and entrusted to UNC Press. For all the hardships and challenges of 2020, we are entering the new year energized and committed to ensuring we live up to that trust in everything we do.



















Sustainable History Monograph Pilot

The Sustainable History Monograph Pilot is an Andrew W. Mellon Foundation—funded initiative to publish open digital editions of high-quality books


from university presses in the field of history. SHMP transforms the publishing process and significantly reduces costs while dramatically accelerating timelines for producing monographs.

The pilot is an opportunity for authors to explore how open digital editions can enhance discoverability and engagement of original scholarship for readers across the globe—while maintaining the high standards of peer review and publication that are integral to university press publishing. Led by UNC Press, SHMP is a partnership with twenty-three university presses who will publish up to 125 history monographs during the pilot.

{The Case for Open Access}

- Unparalleled access to scholarship: New research indicates a sixteenfold increase in usage for open digital scholarship over regular paywalled content. It also reveals high levels of usage in international and underserved geographies.
- Optimized for digital discovery and use: Our workflows include digital-first features such as chapter-level metadata and persistent digital identifiers leading to high levels of digital discoverability and permanence.
- Quantitative analytics: Authors are provided with quantitative impact analytics from a multitude of OA repositories.
- Qualitative feedback: Authors are also provided with qualitative and customized user survey results indicating how books were discovered and used.
- Speed to market: Books in the program are available six to eight months faster than those in standard, printcentric workflows.

Longleaf Services was established in 2006 as a separately incorporated 501(c)3 not-for-profit affiliate of the University of North Carolina Press. Our mission, then as now, is to provide high-quality, cost-effective fulfillment and publishing services for university presses. Providing these services centrally allows the publishers to focus on their core mission of acquisition, editorial strategy, and content dissemination.

From the beginning, Longleaf has provided our client presses with a full range of reliable fulfillment services, including order processing, customer service, credit and collection management, warehousing and shipping, and electronic book file storage and distribution.

In 2015 Longleaf expanded its offerings to include complete editorial, design, and production services; a wide variety of marketing tools and support; and additional operational assistance to the presses we serve. These new services are available to our clients on an à la carte basis and were developed in close partnership with the publishers themselves, to ensure that we are addressing the issues that are most important to them.

Our goal is to provide the best possible service to our clients and, by extension, to all of the end-users of the content they create.

Editorial, Design, and Production

Longleaf EDP provides all interested university presses and libraries with affordable, high-quality production services. Projects can be managed from manuscript through final print and/or eBook files, including hands-on author management. We use/recommend only experienced copyeditors, proofreaders, designers, and indexers. We manage both print and online projects, including books and journals.

The Standard Monograph Program (SMP) was developed to provide the lowest possible pricing on academic monographs without sacrificing quality. This program is ideal for titles that are on a non-rush schedule and don't require a bespoke design or extra services such as proofreading. The SMP workflow is extremely efficient, resulting in significant savings in both time and resources for presses.

The Accelerated Production Program (APP) provides cost-effective production for books and journals that require more individual attention, such as cover design, art redrawing, indexing, proofreading, or shorter schedules. This program nimbly responds to projects that fall outside the parameters of SMP.

Printing Services

Client presses makes their own decisions as to where they choose to print their books and journals. However, we have negotiated preferential pricing and priority press time with multiple printers, offering excellent options to presses that wish to take advantage of them.

Marketing and Sales

Longleaf partners with best-in-class academic sales representatives and print and digital book distributors to ensure that our presses' reach extends to all regions of the globe and to all relevant outlets, including Amazon, national accounts, local independent bookshops and libraries, and everywhere in between. Our rights agent presents titles at Frankfurt, London, and Beijing Book Fairs.

We negotiate reduced group rates, facilitate three-way agreements to help reduce the bureaucracy of getting started with new business partners, and offer in-depth, personalized training and best-practice user forums to facilitate optimization of leading-edge and industry-standard technology. From custom website design and development to maximizing their use of digital and print-on-demand catalog options and e-reader platforms, Longleaf supports our presses' online and old-school marketing and publicity efforts.

Longleaf staff work with presses and their metadata and content partners to dig into the weeds and break down barriers so that all of their books, in all possible physical and digital formats, are easy to discover and order, helping them ensure critical title details are accurate, complete, and compellingly showcased. Our goals align with our presses' when it comes to improving sales, accessibility, and long-term financial sustainability.

We look forward to a post-pandemic world where we'll be able to resume organizing reduced rates on shipping and exhibiting at physical academic conferences so our presses may present their books, authors, and brands live and in person.




















Office of Scholarly Publishing Services

2020 MARKED THE FIFTH YEAR the Press has supported scholarly publishing in the University of North Carolina System through the Office of Scholarly Publishing Services. Creating the office in the first place was a bit of a leap of faith—there are still relatively few programs like it—but John Sherer and Thomas Ross, then system president, identified a need, saw an opportunity, and made the investments necessary to get things off the ground.

Looking back, it is incredibly gratifying to think about how many people we have worked with. Research across the system is truly diverse, and that is reflected in the books and journals that we have helped to produce and disseminate. Whether it is an engineering textbook or a journal that publishes translations of poetry into English, we've handled areas of publishing that frankly would not be a good use of scholars' time and energy—copyediting, typesetting, interior and cover design, indexing, digital conversions, printing, assigning ISBNs and DOIs, and all the other work associated with making scholarly work discoverable and available to audiences

Looking forward, we are working to expand services for open access publishing and journals. Toward that, we have entered into a new partnership with Longleaf Services and Duke University Press to leverage Duke's robust journals platforms and experienced customer service team. We are also excited about the potential of some emerging initiatives that could make a real impact for faculty who publish open access journals. We hope to have more to tell you about that next year.

Our partners at the UNC School of Government are renowned for their publications that educate and inform people working in state and local government, including judicial officials, property tax officials, finance officers, law enforcement, and many more. Under normal conditions, the school hosts classes, workshops, and conferences at UNC—Chapel Hill and across the state. Since the COVID-19 pandemic began, there has been steady and in some cases increased



demand for the school's courses and publications. "We worked quickly with our partners at UNC Press to transition to the remote learning environment by shipping course materials directly to students and increasing ebook availability," said Sonja Matanovic, assistant dean for strategic communications. "We've heard from many public officials who appreciate the flexibility that online learning affords them and the convenience of receiving their books—at work or at home—through the mail."

{Mellon/NEH Grant}

In 2019, we received a Humanities Open Book Program grant from the National Endowment for the Humanities and the Andrew W. Mellon Foundation to reissue out-of-print works from the UNC Studies in Germanic Languages and Literatures series. With our partners at UNC–Chapel Hill's Department of Germanic and Slavic Languages and Literatures and the UNC Library, we have now published 124 monographs, translations, and critical editions in open access and paperback formats. "What a great service UNC Press has provided in making these books available to a new generation of scholars in German studies," commented Eric Downing, chair of the department. "They have been beautifully produced!"









{Reacting Consortium}

Working in the UNC System is our primary mission, but we do selectively work with other nonprofit scholarly publishers. We have published ten textbooks with the Reacting Consortium Press that are used to guide courses using reacting games—interactive role-playing games in which students are responsible for their own learning. The textbooks are used at more than 300 colleges and universities in the U.S. and abroad. Most recently, we published their first open access game book, Food Fight: Challenging the USDA Food Pyramid, 1991. Other topics covered in these engaging courses include the Council of Nicaea, the emergence of modern art, the start of World War I, and the collapse of Apartheid.








{Children's Books}

And while most of our books are for scholarly audiences, some of our partners publish books that educate children. The North Carolina Office of Archives and History recently published two children's books. My N.C. from A-Z by Michelle Lanier celebrates pride of place and North Carolina's rich African American heritage. In Longneedle, Anne Marshall Runyon tells the life story of a longleaf pine in the North Carolina Outer Coastal Plain that is relatable to young readers. And from the Morehead Planetarium & Science Center comes Tony Jenzano, Astronaut Trainer, the story of the man who taught America's first astronauts how to navigate by the stars. We have also started working with the North Carolina 4-H on books for students in 4-H classes ranging from the elementary to high school level.







UNC Press Annual Donor Report

When Brooks Hall closed in March due to coronavirus stay-at-home orders, the Press transitioned surprisingly smoothly because we had already begun exploring remote working for some of our staff. Nothing, however, prepared us for the terrifying drop in sales that followed. Fortunately, by summer, we successfully secured an NEH CARES grant and book sales reversed course and began an encouraging climb. The national focus on #Black-LivesMatter and the widespread press coverage for two of our award-winning titles, Joseph Reidy's Illusions of Emancipation (winner of the Bancroft Prize in History) and Keeanga-Yamahtta Taylor's Race for Profit (finalist for the Pulitzer Prize and the National Book Award) drove readers to our acclaimed list in African American history and our unparalleled titles in the Justice, Power, and Politics series. We also published the first Ferris & Ferris Book, Cool Town by Grace Elizabeth Hale, to great acclaim.

Through all of the turmoil, you were steadfast in providing the margin of excellence with your gifts of financial support—strengthening our day-to-day operations with invaluable, unrestricted support through the Press Club annual fund; enhancing our academic engagement with the UNC campuses by providing scholarly publishing support through the Thomas W. Ross Fund; and nurturing first-time


